

About Senator Rubio Marco Antonio Rubio (born May 28, 1971) is the junior United States Senator from the state of Florida, serving since January 2011, and is a candidate for United States President in the 2016 election. He previously served as Speaker of the Florida House of Representatives. Rubio is a Cuban American native of Miami. He graduated from the University of Florida and the University of Miami School of Law. In the late 1990s, he served as a City Commissioner for West Miami and was elected to the Florida House of Representatives in 2000, representing the 111th House district. Later in 2000, Rubio was promoted to be one of two majority whips, and in 2002 was appointed House Majority Leader by Speaker Johnnie Byrd. He was elected Speaker of the Florida House in September 2005, and served as Speaker for two years. Upon leaving the Florida legislature in 2008, Rubio started a new law firm, and also began teaching at Florida International University, where he continues as an adjunct professor. Rubio ran for United States Senate in 2010, and won that election. In the U.S. Senate, he chairs the Commerce Subcommittee on Oceans, Atmosphere, Fisheries, and Coast Guard, as well as the Foreign Relations Subcommittee on Western Hemisphere, Transnational Crime, Civilian Security, Democracy, Human Rights and Global Womens Issues. He is one of three Latino Americans serving in the Senate. On April 13, 2015, Rubio announced that he would forgo seeking reelection to the Senate to run for President, and he is currently seeking the Republican nomination in the 2016 primaries.

Public Financial Disclosure the Ethics in Government Act of 1978, as amended, requires senior officials in the executive, legislative and judicial branches to file public reports of their finances as well as other interests outside the Government. The statute and the U.S. Office of Government Ethics (OGE) regulations specify which officials in the executive branch file an OGE Form 278. Unlike confidential financial statements filed by some mid-level employees, the OGE 278 is available to the public. Reviewing officials within each agency certify and maintain these reports. Agencies do, however, forward reports of Presidential appointees confirmed by the Senate and certain other reports to OGE for additional review and certification. Although a financial disclosure report sometimes reveals a violation of law or regulation, the primary purpose of disclosure is to assist agencies in identifying potential conflicts of interest between a filers official duties and the filers private financial interests and affiliations. Once a reviewing official identifies a potential conflict of interest and consults with the filers supervisor as necessary, several remedies are available to avoid an actual or apparent violation of Federal ethics laws and regulations. (oge.gov, 2015) OGE Form 278 The purpose of this report is to assist employees and their agencies in avoiding conflicts between duties and private financial interests or affiliations. Agency ethics officials will use the information filers provide to determine whether any potential conflicts exist. The form also will be made available if it is requested by a member of the public. Public requesters are prohibited, however, from using the information on an individual's form for any unlawful or commercial purpose, or from using it as a basis to establish a credit rating or to solicit any money from the filer. (oge.gov, 2015) Report Completeness A presidential candidate may report asset values in wide ranges. In addition, a candidates federal plan, homes, and cars are not required to be on the report. Members of congress are not required to disclose stock transactions in the last 45 days or titleholders on their mortgages.
